### Tender Documents

**Sub: - Arrangement of weekly pest control at Khadya Bhavan (area – 1,82,880 sq. ft. Approx).**

Tenders in sealed covers are invited from the bonafide reputed firms quoting rate per month including GST for undertaking the job of pest control on weekly basis throughout the Khadya Bhavan Building (basement, ground floor to 4<sup>th</sup> floor) measuring an area of 1,82,880 sq. ft. (approx) under Food & Supplies Deptt. Government of West Bengal for destroying mosquitoes & other insects, rodent with a view to restoring suitable office atmosphere.

- 1) **Pesticide Suggested** : Best quality of pesticide materials are to be used for the purpose of pest control.  
**Viz.** a) Zn-Phosphide – to kill and eradicate Rats.  
b) Temprid – to kill Cockroach & others hidden insect.  
c) Bi-Flux (Bayer)- For GPC.  
d) Gokilath for Mosquito larvae.  
e) Vectobac 12AS for Mosquito.  
f) Solfac for Dengue Mosquito.  
g) Glue pad for Senior Officers Chambers to trap Rats.
- 2) **EMD** : A. Prospective bidders shall have to deposit Earnest Money of Rs. 10,000/- (Rupees ten thousand only) in favour of "W.B.E.C.S.C. The Earnest Money so deposited will not carry any interest. The EMD of the successful bidder will be converted into Security Deposit which will be refunded to the Contractor after successful completion of the Contract for 12(Twelve) months and / or any period, if extended.

 f) Pest Control License in Form-viii under rule 10 (4) Insecticides Act, 1968.  
 g) PAN.  
 h) Bank Solvency Certificate from nationalized Bank.  
 i) Aadhaar Card of the Proprietor if the Service Provider is a Proprietorship Concern, Partnership Deed if the Service Provider is a Partnership Firm and Memorandum and Articles of Association if the Service Provider is a Company are to be annexed with the Tender Form.

- 4) **Estimated value of work** : To be quoted by the party on monthly basis including GST as the pattern given below:-
